For Rows 2 and 3: Pursuant to the ordinary resolutions passed at the EGM held on 18 June 2026, the Post-IPO Share Option Scheme was amended and the scheme mandate limit was refreshed, following which, for all share options granted and to be granted on or after 18 June 2026 under the Post-IPO Share Option Scheme (as amended), each grantee shall receive 1 share upon exercising each such outstanding share option. Accordingly, Rows 2 and 3 refer to share options granted under the same Post-IPO Share Option Scheme but respectively before and after the aforesaid amendments, whereas the last column refers to the same available scheme mandate limit at the end of the month for all share options to be granted under the Post-IPO Share Option Scheme.
